297. Fines in respect of paying fee for vacation months.

It is not compulsory for student to pay their fee for the vacation months alongwith the fee for the month during which the college is closed in advance. 298. Principal's authority to strike off the names for long absence.

Principal of a college may, if he so feels struck off the names of a student who remains absent without leave from college for at least six consecutive working days from the roll. Such a student shall not be readmitted until a fresh entrance fee and other charge if any, are paid, provided further that the principal has no objection for the readmission of such a student and there are no other implications involved in it.
